Public Authority/IHSS Update

- Career Pathways: Classes started in Stanislaus County. Attendance was great, 80% of attendees were from Stanislaus County. Payments are being processed as quickly as they can. Payments do come from the State of California. More classes to come in October.
- CICA: Christina attended the meeting. CICA debut their new website in April of 2023.
 Refer to handouts provided by Christina. Gina will forward out information via email to all committee members.
- Provider Performance: Christina asked if there is a provider incentive bonus or increase? Gina: unfortunately we do not have an allocation from the state. Stanislaus County has put in place a Public Authority provider recognition event. Janet suggested maybe a card, plants or cups. Cards being sent out to providers from the IHSSAC. Christina suggested a survey for the purpose identifying a provider who goes above and beyond for the recipients. Further discussion for next meeting
- The budget updates will come down from the state soon. Thus far it doesn't seem there will be any cuts to IHSS.
- AB1005: Proposing when a person is hospitalized with a terminal illness, that the doctor suggest the IHSS program
- AB 1387: Two part bill: attempt to allow undocumented individuals be allowed to care for their undocumented recipients. 2nd part: Opening up a grant opportunity to do out reach.
- AB 1672: IHSS employee/employer relations act. The program is paid thru the state but managed at the county level. Taking that bargaining to the state level with the unions instead of at the county level.
