- Currently in discussions with UDW Possibility of implementing a Spanish session for the Provider Orientation.
- IHSS: Applications have increased. Statewide there is an increase in Minor Children applications
- IHSS currently has an increase in caseloads for our Social Workers.
- CalAIM—IHSS working with managed care plans. Kaiser, Health Net and Health Plan of San Joaquin. Working with them on Memorandums of Agreement (MOU). Plans offer respite care services and community supports to qualifying individuals, include those awaiting IHSS.
- Upcoming changes: State has received authorization to do Telehealth assessment. There are stipulations and criteria that apply. The implementation target July.
- E-Forms: Stanislaus County is currently working with Social Workers to start moving forward with eforms.
- Discussion amongst the group regarding the increase in applications. Our populations is aging and are now at the age of being healthy older adults that still may need help, Medical changing their requirements, which gave our community access to services they may have not been eligible to prior to that change and increased minor children applicants.
